- Each Performance Vested Restricted Stock Unit ("PV RSU") represents the right to receive one share of common stock. One-third of the PV RSU awards will vest based on the achievement by the employee and/or the Company of certain performance targets for each of the fiscal years 2006, 2007 and 2008.
- 11,667 options for common stock ("Options") were issued on February 17, 2004. 8,021 Options were vested as of such date. The remaining 3,646 Options vest at a rate of 730 Options per quarter beginning March 31, 2004. The Options expire on February 17, 2014.
- 12,667 Options were issued on February 17, 2004. 6,334 Options were vested as of such date. The remaining 6,334 Options vest at a rate of 792 Options per quarter beginning March 31, 2004. The Options expire on February 17, 2014.
